TWO-YEAR CRITICAL CARE MEDICINE FELLOWSHIP APPLICATION

Submission of a request to the ABA for prospective approval will require a commitment to meet all the program requirements. The application form must be signed by the Anesthesiology Critical Care Medicine (ACCM) program director, anesthesiology chair, and designated institutional officer.

Programs must receive prospective approval from the ABA before any trainees accepted into the two-year anesthesiology critical care fellowship can qualify for certification under the training pathway.

The pathway to qualify for the ACCM certification examination for physicians trained in ACGME-accredited Emergency Medicine is a minimum of five years in duration. This requires graduating emergency medicine residents who have successfully completed a three-year or four-year residency to:

- 1) complete a 12-month ACGME-accredited ACCM fellowship as well as an additional 12 months in the same fellowship setting, but the 2nd year must be approved by the ABA; **or**
- 2) prospectively complete a two-year ABA-approved fellowship, which incorporates the above requirements.

Please note that to meet the standards for training, institutions that have an ACGME-accredited ACCM training program must also have ACGME-accredited core residencies in anesthesiology, general surgery, and internal medicine.

	The anesthesiology critical care fellowship must have ACGME accreditation and be in good standing at the time of application.
	Nine months of a 12-month ACGME accredited ACCM fellowship in an ICU providing direct care to critically ill patients as per the ACGME program requirements.
	The first six months of the first year, of the two-year ACGME accredited ACCM fellowship should include three months of rotations that have a surgical emphasis such as any combination of the following: acute care surgery (including trauma, transplant and emergency surgical patients); cardiothoracic surgery; neurosurgery; burn or an equivalent experience (please outline). These rotations must involve care of surgical patients; critical care/ICU does not apply for these three rotations.
	<p>A two-year fellowship must have at least 12 months (or rotations) involving a sufficient number of surgical patients. The initial three months with surgical emphasis would count towards this requirement as would any months in surgical, medical-surgical or trauma, cardiothoracic units, neurocritical care, burn or pediatric critical care units that care for a significant number of children requiring surgical care. The remaining critical care rotations may involve the care of non-surgical adults.</p> <ul style="list-style-type: none"> • Rotations in a pediatric intensive care may be counted provided there is sufficient experience with the management of both pre- and post-operative children. • Additional rotations involving the care of critically ill surgical patients such as infectious disease, transesophageal echocardiography, acute pain management in the critically ill, transplant or trauma anesthesia or others will be considered. Supporting documentation for these rotations should be provided. • Perioperative rotations that include the spectrum of assessment and management of the surgical patient could be considered. Supporting documentation for these rotations should be provided.
	Research electives should be limited to a total of no more than two rotations (two months) during the 24-month fellowship.
